# 校長前言 Foreword by The Vice-Chancellor and President

Advances and breakthroughs have been made in cancer research, nanoscience and nanotechnology, life sciences, engineering, social sciences and the humanities, to name a few. Every step of the process has been rewarded with the joy of discovery, which is doubled when the discovery is translated into useful applications and practical solutions. Here at CUHK, we celebrate the spirit of innovation and are proud that we have for four years in a row been named as Hong Kong's most innovative university by Reuters Asia-Pacific.

The University's research excellence is amply recognized by its participation in InnoHK, a major initiative of the Hong Kong SAR government that aims to elevate Hong Kong into a hub of global research collaborations, by converging outstanding researchers from around the world to carry out impactful collaborative research in

InnoHK及AIR@InnoHK兩個創新平台,發展醫療相關的技術、人工智能、機械人科技等。

同樣值得鼓舞的,是大學教育資助委員會2019年7月1日推出第八輪配對補助金計劃,中大迅即籌募得六億港元配對補助金上限。這印證了社會各界對中大的支持,也顯示大學佳績贏得大眾對高等教育和研究的信心。

中大一直不遺餘力,為建設更美好的社會及提升生活質素作出貢獻。中大與香港賽馬會慈善信託基金成立聯合國可持續發展解決方案網絡香港地區分會,說明了我們的決心。我們深信大學不僅是創造新技術和知識的地方,更應積極回應廿一世紀的全球挑戰,致力培育及啟迪引領可持續發展的新一代領袖。

CUHK's strengths in healthcare related technology and artificial intelligence and robotics technology have enabled the University to engage in two innovative clusters, namely, Health@InnoHK and AIR@ InnoHK. Both clusters will be based at the Hong Kong Science and Technology Parks.

Another noteworthy piece of good news is that, with the launch of the University Grants Committee's Eighth Matching Grant Scheme on 1 July 2019, CUHK has already successfully reached its Matching Grant ceiling of HK\$600 million. This achievement speaks volumes about the strength of the community's support for the University, as well as our success in inspiring society's confidence in higher learning and research.

A testimony of CUHK's commitment to social betterment is the co-hosting of the United Nations Sustainable Development Solutions Network (SDSN) Hong Kong Chapter by CUHK and The Hong Kong Jockey Club Charities Trust. The Board consists of successful alumni from different professions and parts of the world, who work together to provide strategic advice and recommendations to the University for translation into actionable initiatives and directions. The Distinguished Alumni-in-Residence Programme is an interactive forum that features alumni who have made notable societal contributions to return to CUHK to deliver lectures, and engage with staff and students to share their wisdom and experience.



# Cell-to-cell signal detected that can lead to poor blood-vessel function in diabetic patients

A team led by Prof. Huang Yu (1st left) revealed a new cell-to-cell communication mechanism that contributes to Type II diabetes. The research shows that the enzyme arginase 1 inhibits the production of essential nitric oxide in the endothelial cells that form the lining of blood vessels, impairing the proper function of the vessels.



# Asia's first microbiota transplantation and research centre

The Faculty of Medicine established Asia's first and Hong Kong's only microbiota transplantation and research centre to unravel the role of gut microbiota in human health, and to develop novel strategies for disease prevention and intervention.




### 快速眼動睡眠行為障礙與 柏金遜症的關聯

醫學院進行全球首個「快速眼動睡眠行為障礙」的家庭研究,調查該行為障礙與柏金遜症的家族遺傳傾向。研究發現「快速眼動睡眠行為障礙」患者的直系親屬,患有柏金遜症和其他腦神經系統退化疾病的風險為其他人的三至六倍。

# Rapid eye movement sleep behaviour disorder linked to Parkinson's disease

The Faculty of Medicine conducted the world's first rapid eye movement sleep behaviour disorder (RBD) family study to investigate the links with first-degree relatives on Parkinson's disease. Results showed that first-degree relatives of RBD patients are three to six times more likely to have Parkinson's disease and other neurodegenerative diseases.

# New photodetector to enhance high-speed optical transmission

A research team from CUHK designed, fabricated, and characterized a new family of integrated waveguide photodetectors that promises exceptional benefits for applications in data centre interconnects and supercomputers. The paper was published in the journal *Optica*.




### 磁性物料淨化污水

### **Purifying water with magnetic agents**

Prof. Wong Po-keung developed natural magnetic agents capable of killing bacteria in waste water, and that the magnetic agents can be easily removed from the water after purification. He is now collaborating with a research team at the Guangdong University of Technology.

### **Manufacturing human tissues**

Prof. Kenneth Lee has worked out how to manufacture human tissue from stem cells, which could lead to the creation of functional patches of tissues for the heart and the liver. He is also working with the Department of Surgery to use stem cells to form soft cartilage that could be shaped into ears to cure a condition known as microtia.

Lung cancer expert Prof. Tony Mok Shu-kam has been instrumental in bringing personalized medicine and targeted therapy to cancer patients. His achievements won him the Lifetime Achievement Award from the European Society for Medical Oncology, and he is the first Chinese to have won the award.




### 醫學院院長以腸胃科醫學 聞名於世

His research excellence has earned him the International Leadership Award from the American College of Gastroenterology, and he is the first Chinese scholar to receive the award.





### Professor named among top 20 researchers for noninvasive test for Down syndrome

Prof. Dennis Lo was named among the Top 20 Translational Researchers by the prominent journal *Nature Biotechnology*, for his development of a robust non-invasive prenatal test for Down syndrome. The testing, which finds fetal DNA in maternal plasma, has been adopted by nearly 10 million pregnant women globally.

### Two psychologists given top honour at International **Association of Applied Psychology**

Prof. Fanny Cheung and Prof. Hau Kit-tai became the first Hong Kong scholars elected as fellows of the International Association of Applied Psychology. The honour is the association's top level of membership, presented only every four years to distinguished scholars who have contributed to the field of applied psychology.

#### **Professors elected IEEE fellows**

Prof. Tsang Hon-ki and Prof. Irwin King of the Faculty of Engineering were elected Fellows of the Institute of Electrical and Electronics Engineers (IEEE) in the class of 2019, for their research contributions towards 'nonlinear silicon photonics and advanced waveguide grating couplers' and the 'theory and applications of machine learning in social computing'.



The team patented BumperCards, a card game that encourages creativity and fun. BumperCards are now distributed to kindergartens and NGOs at a low price, and will be licensed to a corporation.





# Swarming tactic for nanorobots suggests novel delivery of drugs in the body

Prof. Zhang Li (right) developed the use of nanorobots that swarm, allowing them to change shape according to their environment. The tactic presents applications for targeted drug delivery in the body, using a magnetic field to direct particles to the right destination, research that he outlined in the journal *Nature Communications*.



#### Engineer invents digital holography-based nanobuilder

Engineer Chen Shih-chi and his team have developed a digital holography-based 3D nano-builder. The device can combine nano-scale components with complex structures at high speed, useful in fields such as robotics, metamaterials and drug delivery. The invention has also won the R&D 100 Award, dubbed the 'Oscar of Invention', for its ingenuity.

# Breakthrough in plant vacuole biogenesis research may improve crop quality

A team of international researchers led by Prof. Jiang Liwen (centre) made a major breakthrough in revealing the molecular mechanisms of vacuole formation in plants by using 3D electron tomography. Further research on the roles of vacuoles in plants will provide insights into the improvement of crop quality to overcome stressed environments.




## 發表全球首個野生大豆參考 基因組

# World's first reference-grade wild soybean genome announced

An international research team led by Prof. Lam Hon-ming completed the world's first reference-grade wild soybean genome which provides an important tool for soybean genetic research. The discovery may help to improve the tolerance and other agronomic traits of soybeans, thereby extending the habitats of soybean cultivation.

#### Making meat in a test tube

Prof. Kenneth Lee is working with industry to develop edible animal tissue that ranges from fish maw and lab-grown pork. He is also working with a group in Norway to build an 'animal ark' of pluripotent stem cells from as many living species as possible before they are driven into extinction by humans.

# Multi-specialty clinical trial using single port robotic surgical system

CUHK's Faculty of Medicine conducted the world's first multi-specialty clinical trial using the 'Single Port Minimally Invasive Robotic Surgical System'. The trial proved that through the system multiple procedures could be performed through a single entry site, allowing surgeons to reach deep spaces to carry out delicate procedures with precision.




#### 經氣管微波消融術無創治肺癌

## Non-invasive bronchoscopic microwave ablation to treat lung cancer

Thoracic surgical professors from CUHK successfully performed Asia-Pacific's first non-invasive Bronchoscopic Microwave Ablation (BMA) in hybrid operating room for lung cancer treatment. The team made use of thoracic procedures and electromagnetic navigation bronchoscopy to allow high precision delivery of BMA probe into the lung cancer, directly destroying the lesion. The lung cancer treatment is totally scarless.

## New inhibitors to restrain neurodegeneration discovered

Prof. Edwin Chan (centre) discovered a small molecule compound named Anti-polyQ Aggregation for Machado-Joseph-Associated Neurodegeneration (AQAMAN) which can dissociate toxic protein aggregates and restrain neurodegeneration. AQAMAN has the potential to be developed into therapeutic usage, offering hope to patients suffering from Machado-Joseph diseases and other polyglutamine diseases.

# Atropine eye drops proved to reduce myopia progression in children

CUHK's Faculty of Medicine conducted world's first randomized placebo-controlled, double-masked trial on low-concentration atropine eye drops, showing that low-concentration atropine eye drops could reduce myopic progression for school children by nearly 70%.

# Influenza detection kit receives gold award in iGEM competition

A team of 12 undergraduate students from different Faculties was awarded a gold medal at the International Genetically Engineered Machine Competition (iGEM) 2018 Giant Jamboree held in Boston for developing a novel rapid test for influenza subtypes. The tool kit developed by the team can distinguish the subtype of the flu virus in about 30 minutes.





# 目標及策略 Objectives and Strategy

香港中文大學(中大)將遵行以下的使命及願景,作為大學的目標,並制訂適切的發展策略:

The Chinese University of Hong Kong (CUHK) has adopted the following Mission and Vision statements which will continue to guide the University as its institutional objectives in renewing the development strategy:

我們的使命 Our Mission 在各個學科領域,全面綜合地進行教學與研究,提供公共服務,致力於保存、創造、應 用及傳播知識,以滿足香港、全中國,以至世界各地人民的需要,並為人類的福祉作 出貢獻。

To assist in the preservation, creation, application and dissemination of knowledge by teaching, research and public service in a comprehensive range of disciplines, thereby serving the needs and enhancing the well-being of the citizens of Hong Kong, China as a whole, and the wider world community.

我們的願景 Our Vision 努力成為香港、全國及國際公認的第一流研究型綜合大學,並使我校建立於雙語及 跨文化傳統的學生教育、學術成果及社會貢獻,均保持在卓越水平。

To be acknowledged locally, nationally and internationally as a first-class comprehensive research university whose bilingual and multicultural dimensions of student education, scholarly output and contribution to the community consistently meet standards of excellence.

策略規劃是大學上下齊心參與的一個持續過程,而策略計劃書則是此過程的常見成果之一。中大在2016年首季敲定並發表《香港中文大學策略計劃2016-2020》,勾劃出教育、研究(包括知識轉移)、持份者參與等三項大學要務的策略,也闡明實踐策略所需的配合措施。

在教育方面,大學將為學生提供更多學習機會,提升其語文、自學、終身學習等能力,鼓勵他們創新創業,在競爭激烈和急速轉變的世界脱穎而出,貢獻所長。中大是研究型大學,我們將繼續實行前沿研究,特別是中大擅長的跨學科領域,不但在國際學術界發揮影響力,也造福本地、亞洲,以至全球的公民,應其所急,濟其所需。藉着動員社會上各持份者參與大學事務,可加深社會對大學願景和目標的了解,並認同我們的成就。

為了實踐這些目標,我們必須建設有利環境,使人力、財力、物資等**資源**,能妥善分配和運用,確保教學、研究、知識交流的長期成效。大學也將致力保持世界級的校園**基建**,配合我們在資訊時代的學術發展。

Strategic planning is a continuous process which involves participation of, and engagement with, the whole University community, the outcomes of which are normally manifested in the form of a strategic plan. At CUHK, the *Strategic Plan 2016–2020* was published in the first quarter of 2016. The plan sets out our strategies for the core functions of education, research (including knowledge transfer) and engagement, as well as the enabling environment in which these strategies are to be implemented.

Our strategies for education aim to enrich the learning experience for students as well as enhance their language proficiency to develop self-learning skills, lifelong learning commitment and competencies that will make them both innovative and entrepreneurial to flourish in—and contribute to—a globally competitive and rapidly changing environment. As a research-led university we shall continue to engage in cutting-edge research, especially in those interdisciplinary areas identified as our strengths, not only to make an intellectual impact internationally but also to benefit humankind in addressing challenges and societal needs locally, regionally and globally. Through **engagement** with the public we will better articulate, develop and communicate an identity consistent with our visions in order to facilitate the community in understanding our goals and recognizing our achievements.

In order to implement these strategic aims, we shall develop an enabling environment in which our human, financial and physical **resources** are appropriately allocated and deployed to help us attain sustainable excellence in teaching, research and knowledge exchange. Similarly, the University aims to maintain a world-class **infrastructure** that supports our academic endeavours in an information age.

## 財政表現 Financial Performance

大學在2018至19年正值慶祝五十五周年校慶·亦同時標誌着2016至19年三年撥款期的結束。大學在2018至19年財政年度整體錄得綜合盈餘共十億四千萬元及綜合資產淨值共二百二十六億八千萬元。大學憑藉穩健的財務實力,必能面對新的三年撥款期所帶來的挑戰和掌握機遇,在高等教育界保持領先地位。

此財務報表中爐列經常性和非經常性活動 的收入及支出,不論是受政府資助或由非 政府資金支持的。以下各段僅概述大學營運 表現。

大學在2018至19年財政年度總收入較去年增 加九千萬元或百分之零點九至九十六億二千 四百萬元(表一)。政府資助收入共五十一億 二千一百萬元,相比去年增加一億九千四百 萬元,增加的主因是學生人數增加、通漲調 整,以及由於2018年4月和2019年4月公務員 薪酬上調而發放額外整體補助金及增補補助 金。學費、課程及其他收費收入也增加一億八 千五百萬元至二十三億五百萬元,當中百分之 五十四來自非大學教育資助委員會(教資會) 資助課程,而非教資會資助課程因無政府直 接補貼而需按自資營運原則收費,所以學費 收入比教資會資助課程的略高。雖然利息和 股息收益在年內皆上升,但由於中國與美國 在關稅問題上的談判持續及英國脫離歐盟的 不確定性,整體利息及投資淨收益下跌三億 六千四百萬元或百分之四十三點五至四億七 千四百萬元。鑑於第八輪教資會配對補助金 計劃於2019年7月1日才正式推出,捐贈及捐 款收入只輕微增加三千三百萬元或百分之四 點五至七億六千四百萬元,主要用作發展大 學各項科研項目及興建私家醫院。

大學總支出增加六億一千六百萬元或百分之 七點八至八十五億三千萬元(表二),主因是 年度薪酬調整及預算增加的教學、研究及支 In celebration of the University's 55th anniversary, the University is pleased to report that the financial year 2018–19 marked the conclusion of the current triennium 2016–19 with a consolidated surplus of \$1.04 billion and consolidated net assets of \$22.68 billion. The University will leverage on its financial strength to face the challenges in the next triennium 2019–22 and to remain at the forefront of institutions of higher learning.

The financial statements report the income and expenditure for both recurrent and non-recurrent activities funded by the government or supported by other non-government funds. Comments and highlights below only refer to the operating results of the University.

Total income rose by \$90 million or 0.9% to \$9,624 million in 2018-19 (Table 1). Government subventions accounted for \$5,121 million and recorded an increase of \$194 million compared to the previous financial year, mainly due to additional allocations to block grants and supplementary grants to support increase in student numbers, inflation and upward pay adjustments for April 2018 and April 2019. Tuition, programme and other fees increased by \$185 million to \$2,305 million, of which 54% was contributed by non-University Grants Committee (UGC) funded programmes. Fees income from non-UGC funded programmes slightly exceeded that from the UGC funded programmes, due to self-financing tuition fees being charged for the former in the absence of direct subsidies from the government. The interest and net investment income fell by \$364 million or 43.5% to \$474 million arising from the tariff negotiations between China and the United States as well as the uncertainty in Brexit, despite an overall increase in interest income and dividends. In view of the launch of the Eighth UGC Matching Grant Scheme with effect from 1 July 2019, the donations and benefactions income only grew slightly by \$33 million or 4.5% to \$764 million, mainly for research activities and the private hospital construction.

Total expenditure increased by \$616 million or 7.8% to \$8,530 million, attributable mainly to the upward revision of pay adjustment and the planned increase in learning,

大學在2018至19財政年度錄得全面收益合共 十億九千二百萬元(表三),當中包括(在基 金間轉帳前)一億五千三百萬元經常性政府 資助金虧損、三千一百萬元教資會配對補助 金虧損及十二億七千六百萬元非政府資助金 盈餘。 research and support services, as well as for capacity building (Table 2).

Expenditure on learning and research amounted to \$6,767 million and accounted for almost 80% of total expenditure, reaffirming the University's continuous advancement in teaching, learning and research. On the other hand, expenditure on institutional support, including premises and related expenses, student and general education services, and management and general, was kept steady at about 20%.

The University achieved a total comprehensive income of \$1,092 million for the year (Table 3), comprising deficits of \$153 million and \$31 million in recurrent government funds and UGC matching grants fund, respectively, and a surplus of \$1,276 million in non-government funds.

## 財務狀況 Financial Position

截至2019年6月30日,大學總資產淨值 進一步增長十一億元或百分之五點五至 二百一十一億七千萬元。總投資則輕微下 跌三千八百萬元或百分之零點四至八十六 億五千三百萬元,是由於部分港元及人 民幣債券到期、增撥額外資金予投資重估收益。現金及銀行短期存 合及投資重估收益。現金及銀行短期存 款顯著增加二十五億八千二百萬元或百分 之二十六點一至一百二十四億九千二百萬元,主要來自用作興建六幢學生宿舍的教 資會十二億二百萬元一次性撥款。

截至2019年6月30日·大學的固定資產帳面淨值為六十億一千五百萬元,輕微下跌八千八百萬元或百分之一點四。以政府或政府機構附帶條件的撥款購置的固定資產,其帳面淨值將列入遞延資產基金內。截至2019年6月30日,遞延資產基金亦下跌五千七百萬元或百分之一點六至三十五億五千一百萬元。

總結2018至19財政年度的營運表現,一般及發展儲備基金輕微下跌至二十四億三千萬元,教資會配對補助基金為十四億一千萬元及專用基金上升至一百七十三億三千萬元,基金總額達二百一十一億七千萬元,用來支持大學的長遠發展,達成各項策略目標和使命。

The University's net assets increased by \$1,100 million or 5.5% to \$21.17 billion as at 30 June 2019. Total investments dropped slightly by \$38 million or 0.4% to \$8,653 million due to the combined effect of the maturity of HKD and RMB bonds, injection of new funds to investment portfolios managed by external investment managers together with the revaluation gain for the year. The cash and short-term deposits increased significantly by \$2,582 million or 26.1% to \$12,492 million, mainly due to the one-off allocation of \$1,202 million from the UGC for six hostel development projects.

The net book value of fixed assets reached \$6,015 million as at 30 June 2019, a slight decrease of \$88 million or 1.4%. For assets acquired by funds from the government or government agencies with conditions attached, the balances of their aggregate net book value were treated as deferred capital funds. The balance in deferred capital funds decreased by \$57 million or 1.6% to \$3,551 million as at 30 June 2019.

Taking into account the operating results achieved for the financial year 2018–19, the General and Development Reserve Fund dropped slightly to \$2.43 billion, the UGC matching grants fund was maintained at \$1.41 billion, and the total restricted funds grew to \$17.33 billion, with an aggregate total of \$21.17 billion to support the University's long-range development in meeting its strategic goals and missions.

## 未來發展及展望 Future Development and Prospects

香港特別行政區政府對於推動創新及科 技發展不遺餘力,根據2019至20年度的 財政預算案,政府承諾預留超過一千億 元推動創新及科技發展。大學在生物科 技、人工智能、智慧城市及金融科技四大 領域皆已有長足優勢,故此參與政府於 香港科學園設立的兩個創新平台,分別 是專注醫療科技的「Health@InnoHK」 以及專注人工智能及機械人科技的 「AIR@InnoHK」,藉此與世界頂尖大學 及業界合作,為社會開展前所未有的創新 研究。大學亦會把握機會申請政府其他 撥款項目,從而為大學更新校園建設、優 化教學及研究設施、支援公共醫療衛生 及持續研究和發展。大學將全力以赴在 教育和科研中追求卓越和創新。

大學歡迎為十間政府資助的專上教育院校推行的第八輪配對補助金計劃,該計劃在2019年7月1日正式推出。憑着捐款人堅定和慷慨的支持,大學已取得六億元配對補助金的上限。所有的捐款會配合大學長遠策略性倡議及發展。

Pursuant to the government's commitment to promoting innovation and technology development, over \$100 billion was earmarked in the 2019–20 government budget. Given the University's research strengths in biotechnology, artificial intelligence, smart city and Fintech, the University is in an excellent position to partake, inter alia, in two innovative clusters in the Science Park, namely, Health@InnoHK focusing on healthcare technologies and AIR@InnoHK focusing on artificial intelligence and robotics technologies, in collaboration with leading universities and the industries to achieve innovative research targeting for unprecedented societal impact. The University also treasures the funding opportunities available from the government for refurbishing the University campus, enhancing teaching and research facilities, supporting public healthcare and sustaining research and development. The University will spare no effort in achieving excellence and innovation in education and research.

The University welcomes the launch of the Eighth Matching Grant Scheme for 10 publicly funded post-secondary education institutions with effect from 1 July 2019. With the staunch and generous support of our benefactors, the University has already reached the Matching Grant ceiling of \$600 million. The donations will go a long way to augment the University's strategic initiatives and development.

# 風險與應變措施 Risks and Mitigation

風險管理憑着協調有序的活動,以有系統、開誠布公、有紀律的方式,輔助大學 消弭實際和潛在的風險。

2018至19年度,風險管理委員會修訂大學風險管理政策的指引部分,並認可大學2019至20年度的院校風險紀錄冊,而該紀錄冊已獲大學校董會批核。

大學舉辦簡報會及進修課程,分別邀請 新舊學系/單位參加,以推廣大學雙向 (由上至下及由下至上)風險管理,加強 風險管理溝通,培養正面的風險文化。

大學於2019至20年度院校風險紀錄冊內,訂明有關學術、財務、運作等各方面的主要風險事項,其相應之監察及改善計劃已知照司事部門及單位。該等風險事項如下:

- 有關競爭的商業及策略風險
- 有關可持續成長及發展的商業及策略 風險
- 研究路向和道德的學術風險
- 投資的財務風險
- 網上保安、數據安全及完整性等資訊 技術風險
- 環境可持續性的健康及安全風險
- 影響收生的社會及人口風險
- 挽留人才的人力資源風險

Risk management is a series of coordinated activities to direct and guide the University to mitigate against risks, whether actual or potential. This risk mitigation process operates in a systematic, transparent and disciplined manner.

During the year 2018–19, the Risk Management Committee revised the Guidelines Section of the University's Risk Management Policy and endorsed the University's Institutional Risk Register of 2019–20, which had been further approved by the Council.

A number of briefings and refreshing sessions targeting newly invited and current departments/units separately had been organized to promote the two-way (i.e., both top-down and bottom-up) risk management approach. They also helped enhance communication in managing risk and cultivate a positive risk culture inside the University.

For the institutional risk register 2019–20, the University identified the following key risk items in respect of academic, financial and operation, with the monitoring and improvement plan of each assigned to specific risk owners:

- Business and strategic risk in relation to competition
- Business and strategic risk in relation to sustainable growth and development
- Academic risks in research approach and ethics
- · Financial risk in investment
- IT risk as regards cybersecurity, data security and integrity
- Health and safety risk in relation to environmental sustainability
- Social and demographic risks which affect student oppoly
- Human resources risk in retaining talents

## 內部監管及成效 Internal Control and its Effectiveness

大學參考特雷德韋委員會贊助組織委員會(COSO)內部監管綜合框架,並根據 大學結構及運作情況,制訂內部監管措施。為確保內部監管的效率,該框架於以 下三項目標提供合理保證:

- 運作目標——與大學運作效率有關事 宜,包括運作和財務表現目標、保護資 產免於虧損等。
- 匯報目標——關乎向持份者作出的內部及外部財務和非財務匯報,涵蓋可靠度、合時、透明度,以及監管者、認可準則制訂者或大學政策所制訂的其他條件等。
- 合規目標——關乎大學符合法規運作 事宜。

有效內部監管倚仗COSO框架下五個部 分及相關原則的運作,而該五個部分為監 管環境、風險評估、監管活動、訊息及溝 頒、監控等。

自2016至17年度,大學為符合教資會定下的風險管理匯報要求,不斷改善其風險管理及內部監管系統。大學採用較佳的全面風險辨識及評估措施,增加其辨識及監控內部監管的能力,使大學貫徹其策略目標時能把握更多機遇。

大學致力把風險管理及內部監管融合於 學術及研究等範疇的運作中,並以內部 審核確保內部監管系統的效率。在2018 至19年度,內部審計處檢視了大學若干主 要工作,包括斜坡維修、學生宿舍、研究 所、教資會成本攤分指引下的空間庫存 系統,以及依據大學風險管理框架所進 行的合規審查。 The University adopts an internal control based on the COSO (Committee of Sponsoring Organizations of the Treadway Commission) Internal Control Integrated Framework, with due consideration to the University's structure and operation circumstances. For an effective system of internal control, the Framework provides reasonable assurance on various aspects regarding the achievement of three categories of objectives:

- Operations Objectives—pertaining to effectiveness and efficiency of the University's operations, including operational and financial performance goals, and safeguarding assets against loss.
- Reporting Objectives—pertaining to internal and external financial and non-financial reporting to stakeholders, which would encompass reliability, timeliness, transparency, or other terms as established by regulators, recognized standard setters, or the University's policies.
- Compliance Objectives—pertaining to adherence to laws and regulations to which the University is subject.

An effective system of internal control requires the existence and functioning of the five components and relevant principles under the Framework. The five components include the control environment, risk assessment, control activities, information and communication, and monitoring.

Since 2016–17, to comply with the risk management reporting requirement under the UGC, the University has been continuously making improvements to its risk management and internal control systems. The refined holistic approach to risk identification and assessment enhances the University's ability to identify and monitor its internal control, and respond to opportunities as the University pursues its strategic objectives.

The University endeavours to further integrate risk management and internal control into its operation processes, including the academic and research areas, with the internal audit function to assure the effectiveness of the internal control system. In 2018–19, the Internal Audit Office reviewed a number of the University's major operation areas, including slope maintenance, student accommodation, research institutes, space inventory system under UGC's cost allocation guidelines, and also the various compliance reviews in response to the University's risk management framework.

# 大學校董會屬下委員會職能簡述 Brief Descriptions of Council Committees

大學校董會共有十一個向其負責的常設委員會,其 職能簡述如下:

There are 11 standing committees accountable to the Council, the functions of which are summarized below:

#### 行政與計劃委員會

#### Administrative and Planning Committee

行政與計劃委員會依據《香港中文大學條例》成立,協助校長執行其職責,提出大學發展計劃,協助校長審核與統籌大學經常及資本開支的年度預算及補充預算。該委員會亦按《香港中文大學條例》規定,審核或建議某些職級之聘任,並處理大學校董會提交該委員會處理的其他事宜。

The Administrative and Planning Committee is a statutory committee established to assist the Vice-Chancellor in the performance of his duties, to initiate plans of University development, and to assist the Vice-Chancellor in reviewing and coordinating the annual and supplementary estimates of recurrent and capital expenditures of the University. The Committee reviews or proposes certain academic and administrative appointments as stipulated in the Statute before these appointments are made. It also deals with other matters referred to it by the Council.

#### 審核委員會

#### **Audit Committee**

審核委員會審議大學核數師之聘任、核數師收費及 相關事項,檢閱《大學年報》及周年財務報表,按大 學校董會的合理要求,對大學所呈交校董會的財政 資料及財務報表之可靠性,和大學及其附屬體系對 所須遵守的全部法例條文及其他規則,提交所需額 外保證。該會亦負責與大學核數師商討其審核工作 的一般步驟及範圍,檢視大學核數師的查核情況説 明書與大學管理層的回應,檢視內部審核處的工作計劃,以保證內部審核與獨立核數師的協調,以及 承擔大學校董會不時委託的其他有關工作。

The Audit Committee considers the appointment of the external auditors, the audit fee and any other related issues, and reviews the Annual Report and Financial Statements of the University. The Committee offers to the Council such additional assurance as it may reasonably require of the reliability of financial information submitted to it and of financial statements issued by the University, as well as the compliance by the University and its subordinated bodies with all statutes and other regulations to which they are subject. The Committee is also responsible for discussing with the University's auditors the general approach to and scope of their audits, reviewing the external auditor's management letter and University management's responses, and reviewing the internal audit plan and ensuring coordination between internal and external auditors. It shall undertake such other related tasks as the Council may from time to time entrust to it.

### 校園計劃及建設委員會

#### Campus Planning and Building Committee

校園計劃及建設委員會負責處理大學校址整體規劃事宜,並審議與大學發展有關的建築工程計劃。該委員會亦檢視大學建築項目的設備編配及草圖,以及按校長或大學校董會指示就其他建築事宜提交意見。

The Campus Planning and Building Committee undertakes to deal with problems connected with the overall planning of the University site, and to consider the Building Programme in relation to the development of the University. The Committee also examines the proposed Schedules of Accommodation and Sketch Drawings for Building

Projects of the University, and to advise on other building matters referred by the Vice-Chancellor or the Council.

#### 拓展及籌募委員會

#### Committee on Institutional Advancement

拓展及籌募委員會檢討大學就拓展及籌募所制訂與 實施的策略、政策及管治等,並向大學校董會提出 建議。該委員會也向主要持份者推廣捐贈文化,促 進及協調與大學拓展及籌募有關活動和項目,並定 期經校長向大學校董會呈交捐款及資助報告,以及 執行大學校董會及/或校長委派的工作。

The Committee on Institutional Advancement helps to review and advise the Council on the formulation and implementation of strategies and policies related to institutional advancement of the University, and the governance related thereto, to cultivate a philanthropic culture among the major stakeholders, and to promote and coordinate the programmes and activities on matters related to institutional advancement. The Committee is required to submit periodic reports to the Council through the Vice-Chancellor on the donations/ grants made to the University, and take any follow-up actions assigned by the Council and/or referred by the Vice-Chancellor.

#### 大學校董會執行委員會

#### **Executive Committee of the Council**

大學校董會執行委員會獲大學校董會授權,代表大學校董會處理大學日常事務,及就大學校董會討論的策略性事宜向大學校董會/主席提出意見,並向大學校董會就大學校董會及其屬下委員會的空缺提出填補建議。該委員會亦會處理大學校董會不時提交的事宜及向大學校董會報告其獲授權處理的所有事務。

The Executive Committee of the Council is entrusted to deal with routine matters on behalf of the Council, advise the Council/Chairman of the Council on any strategic matters that may be discussed at the Council, and to recommend to the Council on the filling of any vacancies on the Council and Council committees. It also deals with any matters that are referred by the Council from time to time and reports back to the Council on all matters handled under delegated authority.

#### 財務委員會

#### Finance Committee

財務委員會依據《香港中文大學條例》成立及按規 定處理凡屬大學校董會管轄範圍內而又在財務方面 有重大關連之事宜。

The Finance Committee, as a statutory committee of the Council, deals with all matters within the jurisdiction of the Council which have important financial implications.

### 榮譽學位委員會

#### **Honorary Degrees Committee**

榮譽學位委員會負責就頒授榮譽博士學位事宜向大 學校董會作出推薦。

The Honorary Degrees Committee is responsible for recommending the award of Honorary Degrees to the Council.

#### 榮譽院士委員會

#### **Honorary Fellowship Committee**

榮譽院士委員會負責向大學校董會推薦榮譽院士的 人撰。

The Honorary Fellowship Committee is responsible for recommending to the Council candidates for the Honorary Fellowship.

#### 風險管理委員會

#### **Risk Management Committee**

風險管理委員會負責制訂及檢討由大學校董會通過 的風險管理政策:監察及協調所有活動,旨在識別、 評估及緩減可能削弱或有利大學教育、研究、知識 轉移及社區參與之風險;制訂大學的風險管控表, 並最少每年向大學校董會報告。

The Risk Management Committee is responsible for formulating and keeping under review a risk management policy for approval by the Council, overseeing and coordinating all activities aimed at identifying, assessing and mitigating risks that may adversely or beneficially affect the University's ability to achieve its objectives in education, research, knowledge transfer and community engagement, and developing a risk register at institutional level for report to the Council, at least annually.

#### 教職員服務規則委員會

#### **Terms of Service Committee**

教職員服務規則委員會負責檢討薪酬水平等一般服務條件,並向大學校董會提出建議;此外,該委員會也根據校長或大學校董會指示,檢討個別教職員薪酬之事宜。

The Terms of Service Committee is responsible for reviewing and recommending to the Council general conditions of service including levels of remuneration, and reviewing on matters concerning the remuneration of any individual member of staff referred to it by the Vice-Chancellor or the Council.




## 2018至19年度新生入學人數 Student Admission 2018-19

# 2018至19年度學生人數 Student Enrolment 2018–19








