GRANTS FROM U. K.

The Leverhulme Trust Fund of the United Kingdom has offered to The Chinese University of Hong Kong a grant of £16,000 (\$256,000) to establish an academic interchange programme between The Chinese University and British universities for a period of five years.

The offer was accepted by the University Council on November 30.

The Leverhulme Trust Fund is a well-known British institution with the purpose of promoting scholarship and research in British universities.

This support from a British foundation marks the beginning of developing relations and cooperation between The Chinese University and British universities.

"The grant allows the University complete discretion in inviting scholars of any British university to lecture in The Chinese University and in sending our teaching staff to any British university," said the Vice-Chancellor.

"The Chinese University has in the past established exchange programmes with many first rate universities in America; the Leverhulme Grant will now enable us to expand our working relations with British universities."

UNIVERSITY DEANS OF FACULTIES

In accordance with The Chinese University Ordinance, the teaching staff of the university has for the first time elected a Dean for each of the three Faculties of Arts, Science, and Commerce and Social Science. Since many of the professorships and readerships are yet to be appointed, the Senate has resolved that the tenure of office for the Deans during this early period of university development will be one year.

Professor Tang Chun-i, Dean of Arts

Prof. Tang received his B.A. from National Central University in 1932 and then stayed on in his alma mater as Lecturer from 1936-1937. He taught for two years as Lecturer at West China University from 1937-1939. From 1940-1944, he was Associate Professor at National Central University and was then made Professor in 1944. He stayed in the said university until 1949. In the meantime he also taught at Nanking University and Kiang-nan University as Part-time Professor and Professor, respectively.

In 1949, he came to Hong Kong and joined New Asia College where he held the post of Senior Lecturer until 1964. From 1953-1960, he served as a Part-time Lecturer at the University of Hong Kong. From 1959 to date, he has been serving as Head of the Department of Philosophy & Sociology and Dean of the Faculty of Arts at New Asia College. Since 1939 he has been a member of the Philosophical Association of China. In 1959 and 1964 he was a panel member of East-West Philosophers Conference. In 1964 he was appointed Professor at The Chinese University of Hong Kong.

He presented a paper on 'The Development of Ideas of Spiritual Values in Chinese Philosophy' to the East and West Philosophers Conference in 1959. His book 'Philosophy and Culture East and West' was published by the Hawaii University Press in 1963. Other articles published in the New Asia Journal are: 'Hsuntzu's Rectification of Names and Three Schools of Logical Thought in Pre-Chin Philosophy', 'Six Meanings of Li in the Development of Chinese Philosophy', 'A Discourse on the Theories of Mind as Propounded by Meng Tzu, Chuan Tzu, Motzu and Hsun Tzu', 'The Development of Heavenly Mendate in Chinese Thought of Pre-Chin Period', and 'An Interpretation of Argument in Hsiao Chu Chapter of Motze'.

Dr. S.T. Tsou, Dean of Science

A graduate of the Department of Mathematics of the National Sun Yat-Sen University, Dr. Tsou joined the faculty of his alma mater in 1939 and became Lecturer in Mathematics in 1945. In 1950, Dr. Tsou took up a part-time Lectureship at the University of Hong Kong, and a year later became a full-time member.

In 1953, he was awarded a British Council Scholarship and was granted study leave by the University of Hong Kong to engage in research and advanced studies under Professor A.G. Walker at the University of Liverpool, where he was conferred a Ph.D. degree in 1955. He returned to the University of Hong Kong in 1955 and held the post of Lecturer in Mathematics there from 1958-1963.

In September 1963, Dr. Tsou joined the United College as a Senior Lecturer in Mathematics and also assumed duties as Head of the Department of Mathematics and as College Dean of the Faculty of Science. Meanwhile, Dr. Tsou continued his service at the University of Hong Kong until May 1964 as a Parttime Lecturer.

Dr. Tsou's special field of interest is the differential-geometric aspects of Lie Groups and Lie Algebras.

Dr. Yang Ju-mei, Dean of Commerce and Social Science

Born in Tzehsien, Hopeh, 1899, Dr. Yang graduated from the University of Michigan in 1923 with a B.A. degree in Economics, obtained his M.A. degree in 1924 and Ph.D. degree in 1926 from the same University. On his return to China, he taught in the following universities: Chiao-Tung, Chinan, Kwang Hwa, and Shanghai. He had worked as a manager in many banks in China.

He joined the staff of New Asia College in 1949.

His publications: Goodwill and other Intangible Changes in Monetary Value and Problem of Conversion; Accounting in a Free Economy.

INTERMEDIATE EXAMINATION

The Senate, at its meeting on November 2, 1965 discussed at length the reports of the Boards of Studies on the New Teaching Methods (See Bulletin Supplement Volume 1, No. 12—June 1965, and p. 3 of Bulletin Volume 2 No. 2—August 1965). The Vice-Chancellor's summary was tabled.

Matters concerning the Intermediate Examination, to be held at the end of the second year, were resolved as follows:

- (1) The Senate took note of the views expressed by members as to the nature of this examination and agreed that it should be a test of a candidate's general education, his ability to benefit from his course of studies in the University, and his working knowledge of some of the basic principles in the subject field, and that it should not be a test of completence in course work.
- (2) The Senate, in consideration of the views ex-

pressed, resolved that the examination should be composed of two parts: Part I consisting of one paper on Chinese Language and one on English Language; and Part II consisting of one paper on the major subject, one on the minor subject and one on an elective field of studies.

- (3) The Senate agreed that out of the five papers in the Examination the elective paper should be on a subject to be chosen by the student. It might well be a paper on General Education.
- (4) The Senate agreed that passing the examination in both parts was necessary before a student could be admitted to the third year, and that there should be no supplementary examination.
- (5) The Senate agreed that, in order to reduce the number of examinations, Boards of Studies should make recommendations to Colleges as to what course examinations could be eliminated and that it should be left to the Colleges to make the final decision.
- (6) The Senate agreed that the examination should be held at each of the Colleges and that the questions set for the same subject should be identical for all the Colleges and might include a number of elective questions not to exceed 15 percent of the total number of questions set for that paper.
- (7) The Senate agreed that the examination should be held for the first time in 1967, as it was felt that to introduce it in 1966 would be unfair to the present second year students who had not been informed of this examination before.
- (8) As to the proper authority to organize and to conduct the Inter-mediate Examination, the Senate resolved that the Undergraduate Examinations Board (formerly the Degree / Diploma Board) should be entrusted with all the responsibilities connected with the conduct of this examination.


LECTURERS

(In the order of availabity of biographies)

Dr. David Sheng, Chung Chi College, Music.

Dr. Sheng, born in Soochow, did his undergraduate work in music at the University of Shanghai where he received the B.A. degree in 1943. After his graduation, he remained in his alma mater to direct choral organizations and the university orchestra.

He went to the States in 1947 to enter the School of Church Music at the Baptist Seminary in Louisville, Kentucky. Two years later, he received his Master of Sacred Music degree. Subsequently, he was awarded



a fellowship by the Union Seminary in New York City where he did one year's work in the School of Sacred Music. He moved to the west coast to begin his doctoral study at the School of Music of the University of Southern California at Los Angeles.

His study was interrupted, however, in 1955 when he was invited to a teaching post in Taiwan. From 1956 on he was on the faculty of the Taiwan Baptist Seminary in Taipei. While there, he organized and established a music department, which was later elevated to the graduate level, and served as its chairman and graduate professor until the summer of 1962 when he left again for Los Angeles to resume his doctoral work. He finished all requirements in 1964 and was awarded the degree of Doctor of Musical Arts. For his scholastic achievement, he received honors at graduation and was elected by the school to a membership in the Pi Kappa Lambda, the National Honorary Music Society. He is also a member of the Hymn Society of America.

Dr. Sheng joined Chung Chi College in the autumn of 1964 and was charged with responsibility for planning and organizing a Department of Music in the College. After months of work, the proposals were approved by the Chinese University and a Department of Music was officially established in the autumn of 1965. He is now serving as the first full-time Lecturer and, concurrently, Chairman of the Department.

Mr. Su Lin-Kuan, New Asia College, Physics.

Born in Taichow, Kiangsu, 1910, Mr. Su graduated from National Central University in 1932 with a B.Sc. degree in Physics. Upon his graduation, he was ap-



pointed as Teaching Assistant in the Department of Physics. Later he went to Institute of Physics, Peiping Academy, and Metal Institute, Tsinghua University, to do research work.

In 1943, he served as Associate Professor in Szechuan University and in 1944 as Professor in Hsikang Institute of Technology. After the Second World War, he was Professor in Taiwan University and Chiao Tung University. In 1958, he was awarded a United States Government grant under the Fulbright Exchange Program as Visiting Scholar at Yale University. He joined the Staff of New Asia College in 1963.

His publications: The Anisotropy of Spherical Sound Waves (1934), On the Intensity of Sound Emitted during Spark Discharge (1936), Effect of an Electric Lens on Water Jets (1936), The Development of the Fundamental Concepts and Theories in Physics (1954), The Epoch-making Progress of Modern Physical Science (1956), On Basic Science Teaching in Universities (1961), and General Physics for High School (A Text, 1955).

Dr. George H. C. Wong, Chung Chi College, History.

Dr. Wong's educational background are: B.A. in History and Government, Lingnan University, Canton, China, 1949; M.A. in International Relations, The Claremont Graduate School, Claremont, California, 1951; Ph.D. in History, University of Washington, Seattle, Washington, 1958.

Before joining the faculty of Chung Chi College in 1960, Dr. Wong's research and teaching experiences were: Teaching Fellow, University of Washington, 1954-1955; Research Associate, The Human Relations Area Files China Project, University of Washington, 1955-1956; Research Associate, Far Eastern and Russian



Institute, University of Washington, 1958-1960. He was made Chairman of the Department of History and Geography, Chung Chi College, in 1961.

Dr. Wong represented Hong Kong as a delegate to the First International Conference of South-East Historians in Singapore in 1961 and to the Second Biennial Conference of International Association of Historians of Asia in Taipei in 1962. He is a member of several learned societies.

Dr. Wong is spending the 1965-1966 academic year at the Fletcher School of Law and Diplomacy, Tufts University, Medford, Massachusetts, as a Research Associate under an exchange programme sponsored by the Asia Foundation.

Dr. Wong is married, and his wife, a Doctor of Medicine, is teaching Biochemistry at the University of Hong Kong.

ASSISTANT LECTURERS

(In the order of availability of biographies)

Mr. Ian W. Gowers, Chung Chi College, History.

Mr. Ian W. Gowers was born in London and read History at the University of Bristol. He then taught



in secondary schools before coming to Hong Kong in early 1957 to the Department of History and Geography, Chung Chi College, as a lay missionary with the Methodist Missionary Society.

During a study leave in 1961-62, Mr. Gowers investigated the History of Puritanism in Devon 1570-1662 at the University of Exeter. He is a member of the Historical Association (Hong Kong). Since the

summer of 1963, he has also been editor of the College Bulletin and currently serves as Chairman of the Overseas Students Committee.

Mrs. Chow Lin Lien Hsien, Chung Chi College, Chinese Literature.

In 1940, Mrs. Chow was awarded the Chiang Chung Cheng Scholarship to study Literature in the National South-West United University. She later studied Etymology, Phonology and Philology in the National Sun Yet-Sen University and received the B.A. degree in 1944.

Before joining Chung Chi College, she had been a lecturer at the following schools: Kuo Yu Training Institute of Swatow, The Government Evening School of Higher Chinese Studies of Hong Kong, Tak Ming College and Kingsway College of Hong Kong.

Mr. Wong Fai-Ming, Chung Chi College, Sociology.

Mr. Wong was formerly educated in Kwangtung. He came to Hong Kong and studied at Chung Chi



College in 1957. Later he was sent to the University of Redlands, California, as an exchange student and there he was awarded the B.A. degree in 1961. He then did his graduate work in the University of California, Los Angeles, where he completed his M.A. degree in Sociology in 1963.

Since September 1963, Mr. Wong has been on the teaching staff of Chung Chi College. His publications include: "The Chinese Refugee Problem in Hong Kong" (Chung Chi Student, 1960), "Social Problems in Hong Kong" (Redlands Weekly, 1961), "Marriage and Family Systems in South Africa" (Seminar-UCLA, 1962), "Social Ethics of Taoism" (Seminar-UCLA, 1963), and "An Empirical Study of the Relationship Between Attitude and Scale Values" (Chung Chi Journal, 1964).

COLLEGE ADMINISTRATIVE STAFF

(In the order of availability of biographies)

Dr. Robert Dan, M.B., B.S., College Physician, Chung Chi College.

Dr. Robert Dan was born in Hong Kong and was educated at Queen's College. He later studied medicine at the University of Hong Kong. He was awarded the M.B., B.S. in 1960, with distinction, and won the Ho Kam Tong Prize in Social & Preventive Medicine. After qualifying, he held various appointments with the Government Obstetrics & Gynaecology Unit, the University Paediatrics Unit and the Government Medical Unit, all at Queen Mary Hospital.

In 1962, he joined the medical staff of Hong Kong Anti-tuberculosis Association's Ruttonjee Sanatorium.

Shortly after the completion of the College Clinic & Infirmary Building at Chung Chi College, Dr. Dan was appointed the College Physician in 1963 and was entrusted with the task of establishing a College Health Service. Concurrenly, he held the post of Physician-in-Charge at the Children's Garden Hospital of the Christian Children's Fund, Inc. where he helped in the 1964/65 Nutritional Survey, organized jointly by the U.S. Department of Agriculture and the University of Hong Kong.

He later taught at Blair Academy, New Jersy. Mr. Tiong assumed his duty as Assistant Registrar of New Asia College on August 4, 1965.

△ The Ninth Annual Athletic Meet of Chung Chi College was held on Friday afternoon, December 3 and on Saturday, December 4, 1965.

△ At the invitation of United College, the Hon. Wilfred Sien-Bing Wong, Deputy President and Chairman of the British Red Cross Society, Hong Kong Branch, gave a talk on "Red Cross and Blood Donation" to the College students and staff on November 22, 1965.

The Hon. Wilfred Wong traced the history of the British Red Cross Society and its relationship with the International Red Cross Society, with particular emphasis on the significance of blood donation. He pointed out that donation of a small amount of blood has no ill affects on the normal and healthy donor and described the popular dread of blood-giving as unfounded.

His talk ended with an appeal for blood donation, to which the audience gave an enthusiastic response.

△ The Philips Company of Holland donated to United College an Electronics Trainer System which has greatly facilitated teaching at the College. The System was officially opened by Mr. F. van den Akker, Managing Director of Philips (Hong Kong) Ltd. on October 12, 1965 at the College Science Laboratories in Caine Lane. Present at the opening ceremony were members and friends of Philips (Hong Kong) Ltd., the Consul and Vice-Consul of the Netherlands Consulate in Hong Kong, senior Government officials connected with higher education, members of The Chinese University of Hong Kong and its Foundation Colleges, members of the College Board of Trustees, Council and Academic Board.

After introductory remarks by Mr. T. C. Cheng, President of the College, Mr. F. van den Akker addressed the gathering. The intricate workings of the System was demonstrated by Mr. Leung Chi-hong, Demonstrator in Physics. The guests then inspected the Science Laboratories, and had tea and refreshments in the garden.

△ The Students' Union and the Drama Club of Chung Chi presented a four-scene Cantonese play "Thunderstorm" to raise funds for the students' welfare loan at the hall of Queen Elizabeth School for three consecutive evenings as from October 15. A large audience was attracted each evening.
